To maintain the best property we can in Farmington we recently had our yard resodded at no small expense. We also had a sprinkler system installed. In accordance with city regulations we got permission to run the sprinkler system daily for three weeks.

Since the expiration of the permission we have now received two citations for what are minor and inconsequential violations:

First on May 24th our sprinkler system was still operating at 12:15 PM and we were cited.

Second on June 2nd our system ran on an even day and we were again cited.

Both instances were a direct result of the new electronic controlled sprinkler system not being set to the necessary parameters.





Dear City of Farmington Water Board:

I would like to hereby request an administrative hearing before the Farmington Water Board to contest a Water Use citation I received on June 2, 2017. This contestation is based on the grounds that my irrigation service company, Rainmaster, re-activated my system on May 12, 2017, and without my knowledge changed the programming to occur on even days instead of the odd days I had programmed last year. I was wrongly told that the system was set correctly and therefore had no reason to suspect I was in violation of any restrictions.

As a secondary contestation I would like to strongly protest to the assessment of fees on this first offense, when a warning or notice would have been sufficient to cause immediate corrective action on my behalf. I fully understand the need for fees on repeat offenses due to the administrative overhead incurred, but there should be a grace period to allow those that honestly try to follow the rules to not be penalized without warning.

I appreciate your thoughts and consideration on this matter, and I await your decision to either grant a hearing to discuss further or dismiss this citation on the grounds I have listed.


To whom it concerns,
